Call to Order: Dennis Flabetich

Dennis Flabetich called the meeting to order at 12:35 p.m. and welcomed everyone to the meeting. Introductions were made.

Approval of Minutes: Dennis Flabetich

Dennis called for a motion to approve the April 13, 2015 meeting minutes:

Tony Edwards moved to approve the April 13, 2015 Executive Committee Meeting minutes as printed, seconded by Barb Cosner. Motion carried.

Consent Agenda

15-05-01 Finance Report

To adopt the SCWDC Finance Reports as submitted for period ending March 31, 2015.

Linda Kaminski moved to approve the items on the Consent Agenda as presented, seconded by Jim Sizemore. Motion carried.

Board Development Committee: Linda Kaminski

Linda shared that the Board Development Committee met. She reviewed the provided memo describing the work they performed. The following three motions were a result of their work.

Tony Edwards moved to eliminate the Youth Council; and establish a Youth Committee as described in the WIOA Legislation; and that it be composed of the following seven seats:

- 1. Board Member, Chair, Required Seat**
- 2. Community Based Organization that Serves Youth, Required Seat**
- 3. Juvenile Justice Center**
- 4. Secondary Education System**
- 5. Post-Secondary Education System**
- 6. Vocation Rehabilitation**
- 7. Member at Large – drawn from the community that may represent business, Job Corp, parents, or other categories deemed relevant to the matters of youth employment.**

Seconded by Barb Cosner. Motion carried.

Jim Sizemore moved to reconstitute the WorkSource Oversight Committee as a new One-Stop (WorkSource) Committee; and that the membership include 12 members with the 4 required seats (core partners), and the remaining seats come from required WIOA national programs that are present in the area; and have the authority to commit or gain commitment from their organization; to formalize and negotiate partnerships and, the one-stop operator shall serve as an additional non-voting ex officio member, seconded by Dennis Flabetich. Motion carried.

Marcia Henkle moved to establish a standing committee for Individuals with Disabilities, and a board member will chair the committee and, other members/representatives shall come from partner organizations with expertise in serving people with disabilities, as well as representatives of agencies that serve this population, seconded by Tony Edwards. Motion carried.

Approval of the PY15 Request for Proposals: Christine Cote

Patrick shared that this past fall staff recommended the postponement of procurement until the new legislation. Since that time after talking to John Chamberlin and others, staff has decided that it would be best to move forward. There are currently two procurements going on. The first is for the Youth Program in Lower Yakima County and Upper Yakima/Kittitas Counties. The seconded is a comprehensive proposal for the Columbia Gorge including Youth, Dislocated Worker, Adult and WorkFirst programs.

The WIA programs will be allocating 80% in order to keep some funds back to cover all of the expenses such as business engagement and incumbent worker training.

The release date is May 5th. The due date is May 26 by 4:00 p.m. The contract period is July 1, 2015 – June 30-2016. There will be a Bidders Conference on May 12 at 1:30 p.m.

All proposals will be approved by the Board and the Consortium.

Dave McFadden moved to approve the “Workforce Innovation and Opportunity Act Youth, Dislocated Worker, Adult and WorkFirst Programs” Request for Proposal for the Columbia Gorge for release May 5, 2015, seconded by Tony Edwards. Motion carried.

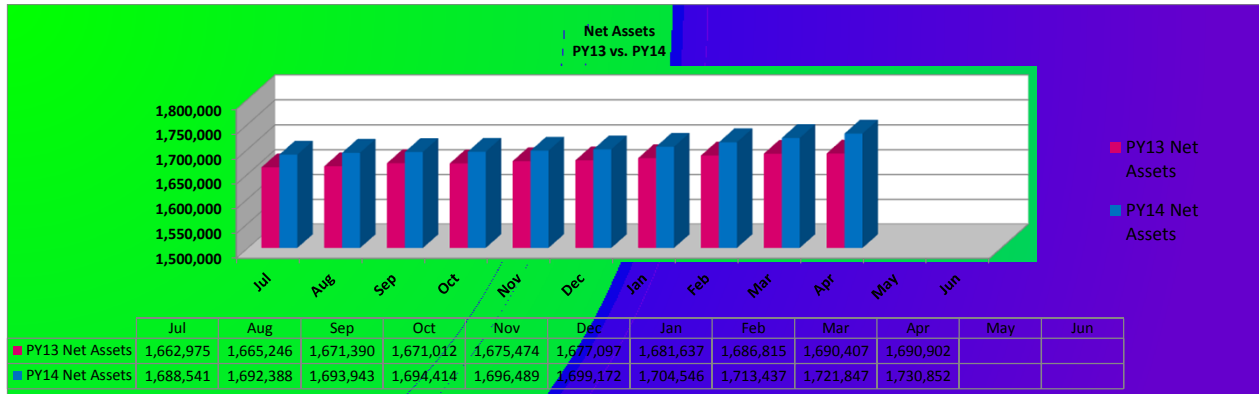

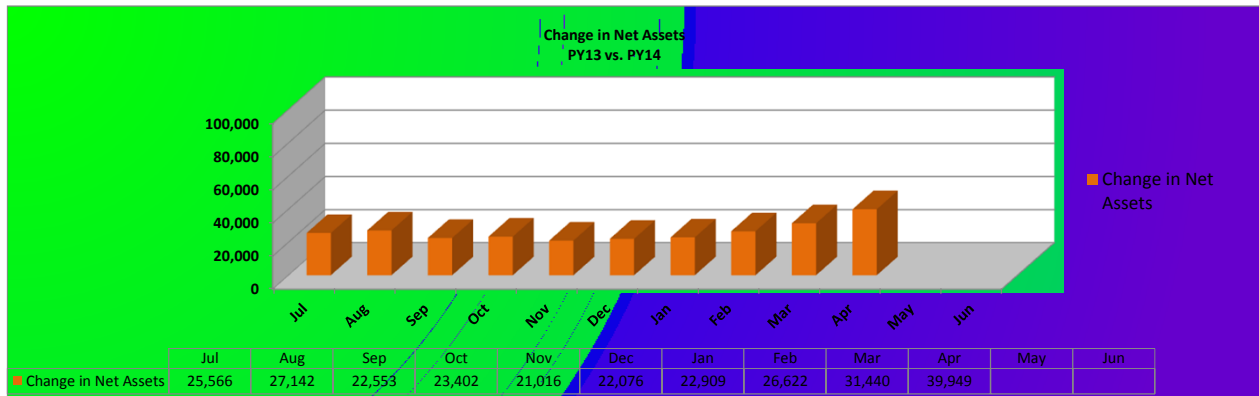

SUBJECT: Recommendation Contract Award for Program Year 2015 Workforce Innovation and Opportunity Act Youth, Dislocated Worker, Adult, and Commerce WorkFirst programs

I. PROPOSAL REVIEW

The South Central WDC Youth Council/Committee comprised of Craig Dwight, John Pascua, Eileen Fielding and Bryce Humphreys met on June 2, 2015 to review and rate proposals for the PY15 WIOA Youth programs for Upper Yakima/Kittitas County and for Lower Yakima County.

Upper Yakima/Kittitas County Youth Proposal Review

Only one proposal from OIC of Washington for Upper Yakima and Kittitas County Youth Program was received. Staff provided a technical review and reported the proposal met the technical requirements of the RFP. The committee publically commented and scored the proposal 340 of 400 possible points. After comments were concluded the committee unanimously voted to award the contract to OIC of Washington.

Lower Yakima County Youth Proposal Review

Only one proposal from Yakima Valley Farm Workers/NCAC was received for the Lower Yakima County Youth Program. Staff provided a technical review and reported the proposal met technical requirements of the RFP. The committee publically commented and scored the proposal 336 of 400 possible points. After comments were concluded the committee unanimously voted to award the contract to Yakima Valley Farm Workers/ NCAC.

The South Central WDC Planning Committee comprised of Christine Cote, Carolyn Dresker, Denny Newell, Gregg Broyles and Craig Dwight representing the Youth

Committee met on June 5, 2015 to review and rate comprehensive proposals for the Youth, Dislocated Worker, Adult and WorkFirst programs in the following area for Klickitat and Skamania Counties (Columbia Gorge).

Klickitat/Skamania County (Columbia Gorge) Proposal Review

Only one proposal from People For People was received for the Klickitat/Skamania (Columbia Gorge) area for WIOA Youth, Dislocated Worker, and Adult Programs; and Commerce WorkFirst programs. Staff provided a technical review and reported that the proposal met the technical requirements of the RFP. The committee publically commented and scored the proposal a total of 423 of 500 possible points. After comments were concluded the committee unanimously voted to award the contract to People for People.

II. Sole Source

The board needs to be aware that since only one proposal was received for each RFP, under procurement rules this is considered a failed procurement. Under this condition the board can reissue proposals or award contracts on a Sole Source Basis.

III. Committee Recommendations

1. Youth Council/Committee Recommendation for Upper Yakima and Kittitas County

The South Central Workforce Council Award (sole source) the PY15 Upper Yakima and Kittitas County WIOA Youth Program to OIC of Washington based on successful negotiations; and concurrence by the South Central Consortium of County Commissioners

2. Youth Council/Committee Recommendation for Lower Yakima County

The South Central Workforce Council award (sole source) the PY15 Upper Lower Yakima County WIOA Youth Program to Yakima Valley Farm Workers/NCAC based on successful negotiations; and concurrence by the South Central Consortium of County Commissioners

3. South Central Workforce Council Review Committee Recommendation for Lower Klickitat and Skamania Counties

The South Central Workforce Council Award (sole source) the PY15 WIOA Youth, Dislocated Worker, and Adult Programs; and Commerce WorkFirst programs to People For People based on successful negotiations; and concurrence by the South Central Consortium of County Commissioners

SUBJECT: Approval of PY15 Dislocated Worker and Adult Program Allocations

The South Central Workforce Council has received WIOA preliminary allocations for PY15 Dislocated Worker and Adult Programs which begin July 1, 2015.

Dislocated Worker program allocations reflect an overall increase of 41% and Adult Program funds increased by 9%. The allocations come with limited first quarter (July – September) funding to the WDC, Dislocated Worker programs 20% and Adult program, 8%. With these limits in first quarter funding, particularly for our Adult Program, the WDC will need to be strategic in mitigating this limitation of funding through use of available PY14 carry in funds, DW State mitigation funds and other.

Please note, that with the procurement of our Dislocated Worker and Adult Programs, successful bidders are anticipated to begin operating these programs October 1, 2015. Therefore, staff is requesting to **allocate** Dislocated Worker and Adult PY15 WIOA to current providers for one quarter (July 1, 2015 – September 30, 2015).

Additionally, in an effort to get services in place by July 1, 2015, staff is requesting to enter into new one quarter (July-September) **agreements** with current individual program operators with allotments based upon historical percentages and client demand for services. Staff will negotiate the deliverables for enrollments, trainees, job placements and other, with each service provider.

SUBJECT: **PY15 WIA Youth Program Allocations – Revision 1**

We have received our PY15 current state allocation for the WIOA Youth Program for a total amount of \$1,073,385. Of this allocation \$966,047 is Program funds and \$107,338 is Cost Pool funds. Of the Program funds, 80% (\$772,838) is allocated to the recommended Youth Contractors (below) based on their service area with 20% of the program funds retained at the SCWDC level. The program funds retained is used to charge program related tasks at the WDC level.

The funding has been allocated by County according to State formulas.
